

MIXING: Fill spray tank 2/3 full, add the desired amount of herbicide and continue filling. Add Crop Oil Concentrate last. After filling, continue agitation, unless instructed otherwise by pesticide label. Always follow pesticide label directions, acceptable practices and advice from your crop consultant.
